WHEREAS, Reseller can purchase proprietary products from DrMiller.com at a discount and be able to sell them either from Reseller's storefront or website.

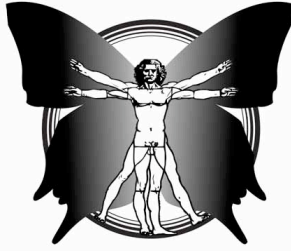
